(No Necklaces, Rings, Earrings, studs, lip, eye, tongue rings, etc....)</p> <p>Generally, no powered items, glass containers, flammables, caustics or hazardous materials, aerosols, or alcohol based items will be allowed.</p> <p><u>Specialty items not listed must be cleared in advance by the Security Coordinator. Items not approved or on the approved list may be subject to confiscation as contraband or shipped out at the clients expense.</u></p> <p><u>The following food and hygiene items are typically not authorized for receipt by CCP west clients from outside sources.</u></p> <ol style="list-style-type: none"> 1. Sugar, cereal, perishables, canned goods, baked goods and items requiring freezing and/or refrigeration. 2. Items containing high percentages of alcohol and/or items containing toxic, flammable and or caustic chemicals. 3. Sharp objects, glass and/or breakable items and/or containers which pose a safety hazard when processing the property. <p><u>Food items sent in are limited to a 12x12x8 box. Food items are limited to what is in the vending machine.</u></p> |
