Jewelry other than items 8, 9, and 49 is not allowed. (No Necklaces, Rings, Earrings, studs, lip, eye, tongue rings, no wrist bands etc.)

Specialty items not listed must be cleared in advance by the Security Coordinator. Items not approved or on the approved list may be shipped out at the Family Member's expense. The following food and hygiene items are typically not authorized for receipt by CCP East Family Members from outside sources.

1. Sugar, cereal, perishables, canned goods, baked goods, and items requiring freezing and/or refrigeration.

2. Items containing high percentages of alcohol and/or items containing toxic, flammable and/or caustic chemicals.

3. Sharp objects, glass and/or breakable items and/or containers which pose a safety hazard when processing the property.

4. Hygiene products will not be allowed at intake if they are used or have been opened.
